# **Bandits+ GIVEAWAY - Terms and Conditions**

## **GENERAL**

FIELD OF DREAMS AUSTRALASIA PTY LTD Trading as The Brisbane Bandits (ABN 34 659 352 922) of Unit 2, 60 Alexandra Place, Murrarie, QLD 4172, (hereinafter referred to as 'We' or 'Us' or 'Our'), is conducting a trade promotion by way of a lucky draw (hereinafter referred to interchangeably as the 'Contest' or 'Giveaway') for individuals (hereinafter referred to as 'Participant' or 'Participants' or 'Members' or 'Entrants' or 'Them' or 'You' or 'Your').
